

## [Bob Evans Grilling Contest]

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

### 1. HOW TO ENTER

- a. The Bob Evans Grilling contest will begin on [6am (EASTERN TIME) /May 11, 2009] and end on [10am (EASTERN TIME)/August 28, 2009].
- b. To participate in the contest, you may enter via the following method(s):  
[Contestants should email their favorite recipe that includes the featured Bob Evans grilling product of the week to \_\_\_\_\_].  
Enter your first name and last name, complete address, city, state, zip code, home telephone number and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address.
- c. The Station is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches.
- d. [Only one entry per email address for each week.]

### 2. ELIGIBILITY RESTRICTIONS

- a. The contest is open to all persons who are [18] years of age or older and who reside in [Pennsylvania]. Employees of [WDSY-FM] (the "Station"), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Pittsburgh metropolitan area and the members of their immediate families [AND/OR HOUSEHOLDS] are ineligible to participate or win.
- b. [Listeners can only win one prize every 30 days] Only one winner per household is permitted in any Station contest.
- c. Contestants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the

eligibility requirements, and the Station will also delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

### 3. PRIZES

- a. **[Each week a Bob Evans Grilling Prize Pack will be awarded. This prize pack includes 5 pack of sausage and brats, plus one bottle of wildfire sauce. 16 weekly prizes will be awarded. Each prize carries a value of \$33]**
- b. All prizes or prize certificates may be picked up at the office of the Station at the address below. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer, or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of Station management with respect to the contest are final.
- b. **[Each Friday throughout the duration of the contest, we will randomly select a winner from the submitted recipes]**
- c. **[Odds of winning are determined by number of valid entries]**
- d. **[Winner need not be present to win]**
- e. **[Winners will be contacted by phone. IF APPLICABLE, INSERT:**  
"Winners must execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form within ten (10) days of notification attempt or prize will be forfeited and an alternate winner may be chosen by [random selection]."]

### 5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. Winners may be required to sign an IRS Form W-9 or the equivalent.
- b. By participating in the contest, the winner or winners agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this contest without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, the Station in its sole discretion may require contest winners (and their travel companions, if any) to sign a liability release, agreeing to hold the Station, its corporate licensee, its parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.
- d. The Station, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the Station's Web Site or is otherwise in violation of the rules.
