

CABELA'S WINTER HOLIDAY CONTEST

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. HOW TO ENTER

- a. The Cabela's Winter Holiday contest will begin on Thursday, November 26, 2009 at 12:00 A.M. and end on Thursday, December 10, 2009 at 11:59 P.M.
- b. To participate in the contest, you may enter via the following method(s): Log on to y108.com and upload a picture of your prize hunt/catch (photo of you with the animal that you caught) and complete the registration form. Enter your first name and last name, complete address, city, state, zip code, home telephone number and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address.
- c. The Station is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches.
- d. One entry per person/household.

2. ELIGIBILITY RESTRICTIONS

- a. The contest is open to all persons who are 18 years of age or older and who reside in the Greater Pittsburgh Metropolitan listening area. Employees of WDSY-FM (the "Station"), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Greater Pittsburgh metropolitan area and the members of their immediate families and/or households are ineligible to participate or win.
- b. Listeners can win on one of the CBS Radio-Pittsburgh stations once every 60 days. Only one winner per household is permitted in any Station contest.
- c. Winner will be required to sign a participant release when claiming the prize.

- d. Contestants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements, and the Station will also delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer, or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of Station management with respect to the contest are final.
- b. Winner will be at random from all eligible entries received.
- c. Odds of winning depend upon number of entries received.
- d. Winner need not be present at time of drawing to win.

- e. Winners will be notified via email address provided on the entry form. If there is no response within 24 hours, we will attempt to reach the winner by phone number provided on the entry form. If there is still no response within 48 additional hours, an alternate winner may be chosen. Winners must execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form within ten (10) days of notification attempt or prize will be forfeited and an alternate winner may be chosen by random drawing from all remaining entries.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. Winners may be required to sign an IRS Form W-9 or the equivalent.
- b.
