



OFFICIAL CONTEST RULES

1. How to Enter the Contest:

- a. The weekend Y108 gives listeners chance to win various prizes. To win winner must be caller 18 after Disc Jockey says to call in. The number to call is 412-333-y108.
- b. To participate in the contest, listeners be caller 18 and answer the trivia question correctly.
- c. No purchase necessary. Listeners can win once ever 60 days.

2. Eligibility Restrictions:

- a. The contest is open to all WDSY listeners who are 18 years of age and older (unless otherwise noted) who reside in the Greater Pittsburgh Area. Employees of WDSY, CBS Radio, its parent corporation, Viacom Inc, affiliated entities, its affiliated advertising agencies, participating sponsors/promotional partners,, other radio stations in the Pittsburgh metropolitan area and the members of their immediate families are ineligible to participate or win.
- b. Listeners are eligible to win a WDSY contest only once every sixty days.
- c. Only one winner per household is permitted to win every 60 days.
- d. Listeners are eligible to win a prize valued at \$600 or more only once every six months.

2. Prizes

- a. The winner will receive the prize pack revealed by the disc jockey during the broadcast.
- b. In cases of a grand prize, all winners will be qualified and a random drawing will take place on the following Monday .
- c. 15 Qualifiers will be chosen per weekend
- d. Contest prizes are not transferable. Prizes may not be substituted for or redeemed for cash. WDSY reserves the rights to substitute any prize or prizes of equal or greater value.

3. Selection of Winner:

- a. Decisions of station management with respect to the contest are final.
- b. If caller 18 is ineligible, caller 19 will win.

5. Conditions

- a. Payment of all federal, state and local taxes are the sole responsibility of the winner. Winners may be required to sign an IRS Form W-9 or the equivalent.
 - b. By participating in the contest, the winner or winners and their guest, if any, agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this contest, and without additional financial or other compensation and to sign a publicity release prior to acceptance of the prize.
 - c. Contest winners and their guest, if any will be required to sign a liability release prior to acceptance of any prize valued at \$600 or greater or which prize includes the provision of transportation, whether or not such transportation is provided by WDSY. Pursuant to the liability release, the winners will agree to hold WDSY, CBS Radi Inc., Viacom Inc., affiliated companies and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.
